

Announcement of Surindra Rajabhat University

No. 027 /2024

Subject: Policy of Not Giving or Accepting Presents and Gifts to Personnel (No Gift Policy) in the Budget Year 2024 (B.E. 2567)

Providing the service party of Surindra Rajabhat University conforms to purposes by section 7 of the Rajabhat University Act 2003 (B.E. 2547), including consistent national reform to anti-corruption and misconduct. I would like to announce the intention of the administrators, lecturers, and personnel of Surindra Rajabhat University not to give or accept all kinds of presents and gifts (No Gift Policy) to build good culture and values at our university. Personnel should be integrity, morality, and transparency for protection behavior that can influence discretion or decisions which can lead to discrimination or cause benefits that overlap the anti-corruption and misconduct by strictly adhering to the following practices:

- 1. Surindra Rajabhat University's announcement is entitled Policy of Not Giving or Accepting Presents and Gifts to Personnel (No Gift Policy) in the Budget Year 2024 (B.E. 2567).
 - 2. This announcement is applicable from 28 December 2023 (B.E. 2566).
- 3. To cancel the Announcement of Surindra Rajabhat University entitled Policy of Not Receiving and Accepting Presents and Gifts to Personnel (No Gift Policy) in the Budget Year 2024 (B. E. 2567), that announcement or commands that contradict this announcement for use this announcement replace.
 - 4. In this announcement refers to the following:
 - "University" means Surindra Rajabhat University.
 - "President" means the President of Surindra Rajabhat University.
 - "Giving" means the intention to give property by attracting recipients.

"Presents and Gifts" means money or property to give for hospitable friendship to be given as a gift by attractions, support, or in gratitude and meaning any other benefits that can be financial.

"Property" means the properties according to the Civil and Commercial Code, which is the property of digital assets regarding businesses' digital assets.

"Traditional" means the festival or special day with a gift and an opportunity to congratulate, thank you, welcome, and regret or socialite's support.

- 5. Administrators, lecturers, and personnel of Surindra Rajabhat University will not seek the opportunity to receive presents, gifts, or other benefits unlawfully.
- 6. Administrators, lecturers, and personnel of Surindra Rajabhat University will not accept all kinds of presents and gifts or any other benefits from the visitor's contact party with Surindra Rajabhat University during friendship's contact on duties and before and after working.
- 7. Administrators, lecturers, and personnel of Surindra Rajabhat University will not give presents and gifts or any other benefits to the administrators and the friendship's owner.
- 8. Administrators, lecturers, and personnel of Surindra Rajabhat University will not be supporting the parents' owner, accepting or giving presents and gifts, or any other benefits to persons, which can lead to discrimination that overlaps with anti-corruption in the present and future.
- 9. Congratulations, expressing great desire, welcome, and regret of any opportunity by tradition, are advised to use greeting cards, any documents, or it is on social media. That replaces the presents and gifts.

In cases where it is necessary to give or accept property or any other benefits according to morality or tradition, all must comply with the regulations of the Office of the Prime Minister regarding giving or receiving gifts of government officials 2022 (B. E. 2565) and the Announcement of the National Anti-Corruption Commission on the criteria of giving or accepting property or any other benefits according to the morality of government officials 2020 (B.E. 2563).

10. The president of this announcement is authorized to make the final decision as follows: If an interpretation of this notification is required, the president shall have the authority to decide if there is an issue with the implementation of this announcement or if this announcement is not described. The president has the authority to make the final decision.

The administrators' behavior is a good precedent, as well as overseeing them under control to conduct themselves strictly by this policy.

This Announcement was made on 19 January 2024.
